




Identification glossary

- IDUL: Identifiant Unique ULaval, it consists of a maximum of eight characters and is generally made up of five letters followed by zero to three digits. It is used to access many of Université Laval's IT services.
- Password (NIP): it is used as a password in several Université Laval systems. In particular, it is used to access monPortail.
- NI: Numéro d'identification, it consists of nine digits and is indicated on your official documents. The NI appears on the Université Laval identity card issued at the beginning of the session.

Admission and registration

Two distinct processes:

Admission offer: confirms your eligibility to study in a program and allows you to begin the process of coming to Canada.



Registration: consists of choosing the academic activities (courses, internships, writing and research activities) you will engage in during a semester. **Must be completed before each new session, throughout your studies**.



Your first registration

- By your Faculty's academic advisor
- By **yourself** in <u>monPortail</u> (Identification with your IDUL and password)
- To validate your choices, we recommend that you contact your <u>Faculty's academic</u> <u>advisor</u>.
- Once you've accepted your admission offer, keep an eye on your @ulaval.ca e-mail inbox. Your program director will provide you with useful information to help you prepare for the upcoming session and choose the courses you will take.
- If you have any questions about MonPortail, meet our welcoming team at Pavillon Maurice-Pollack, room 1106, from August 25 to September 1st.



Knowledge of French

- ➤ Université Laval is a French university. Although some classes and reading can be offerded in English, most of the classes and interactions are in French.
- ➤ Also, Québec city is mostly unilingual in French. You have to be able to use simple words to get around in the city.
- You may be required to take a language test or complete a course of french to obtain your diploma. Consult your academic path on <u>MonPortail</u> or contact your <u>academic</u> <u>advisor</u> to make sure if this is your case.

Fees

Proper planning is essential to ensure you have the financial resources necessary to meet your needs and pay for your studies. Be sure to review the detailed information available about your tuition and other fees.



FEES

Sample expenses

Here are examples of essential expenses to plan for your study project, according to your student profile, in order to know the income that will be necessary to balance your budget throughout your academic career. These examples are intended to inform you about the cost of living in Quebec City, employment income and savings to plan. Ask your faculty, national government and grant agencies about funding opportunities.

Family

Please note: daycare centers in Quebec are not free! There are both subsidized and private daycare centers. Places are hard to find.

Register as soon as possible at <u>place0-5.com</u> or plan a financial or family alternative.

Rates can run from \$45 to \$80/day.

Primary and secondary education is free. However, fees will be charged for the purchase of mandatory materials, as well as for pre-school, lunchtime and after-school care.



INSURANCE

Régie de l'assurance maladie du Québec (RAMQ)

For citizens of countries that have signed a reciprocal agreement with Quebec:

- ✓ Belgium, Denmark, Finland, France, Greece, Luxembourg, Norway, Portugal, Romania, Serbia and Sweden.
- ✓ Contact your health organization to find out if you are covered by the reciprocal agreement. Before you leave, you need to obtain a certificate of affiliation to your country's social security plan.
- Consult the Web site for more information
- Do NOT go to the RAMQ offices; registration is done online, once you have arrived in Quebec.
 - Send proof of eligibility to the Registrar's Office by e-mail to assurances@reg.ulaval.ca no later than September 30, 2025.

If you plan to arrive in Canada before RAMQ comes into effect, you'll need to take out **private** insurance. See our <u>page on this subject</u>.

Complementary insurance: Alliance pour la santé étudiante au Québec (ASÉQ)

Not for exchange students.

- DENTAL and HEALTH CARE automatic, but not mandatory, withdrawal possible on request. This insurance includes the Wellness Program
- Withdrawal: Withdrawal can be requested from September 15 to October 15.

Health insurance for family members



You MUST insure any <u>family members accompanying you to Quebec</u>.

• CHILD less than 17 years old:

Minor children are eligible for health and medical insurance (RAMQ, free public plan) if they are present in Quebec for more than 6 months per year.

• Other family members:

May also be eligible for RAMQ if they have authorization to stay in Canada (work permit, study permit or visitor record) and are listed on your reciprocal agreement form (with the exception of spouses of students from Greece). Dependent children between the ages of 18 and 25 may also be eligible if conditions are met. Registration is online at https://www.ramq.gouv.qc.ca/en/citizens/health-insurance/register.

• An application form must be completed for each family member.

HOUSING

Finding an accomodation




Warning: There is currently a housing crisis in Quebec.

- <u>On-campus housing</u>: You can reserve a room at Université Laval residences.
- Off-campus housing: If you're arriving with your family or would like to live off-campus, take a look at the various housing search platforms in Quebec City.
- <u>Temporary stay at your arrival</u>: If you arrive in Quebec City without accommodation, you'll need to find a temporary alternative. Check out these alternatives.
- <u>Home insurance</u>: We <u>strongly recommend</u> that you take out home insurance to cover possible damage to your home or theft. Even students living in university residences should take out such insurance.

Locate Université Laval

Look for housing near bus routes 800, 801, 804 and 807. Montcalm, Saint-Jean-Baptiste, Sainte-Foy, Saint-Roch, Saint-Sacrement and Old Quebec are the areas closest to ULaval.

However, they are also among the most expensive neighborhoods. If you can't afford to live there, Saint-Sauveur, Beauport and Limoilou, as well as the South Shore of Quebec City (Lévis, Saint-Romuald, Charny) are often more affordable. You'll need to plan your bus travel time accordingly.



CHOOSING YOUR ARRIVAL DATE

Prepare for your stay



Choosing your arrival date

- ✓ We recommend that you arrive at least 1 to 2 weeks before the start of the class.
- ✓ If you wish to arrive in Canada before the effective date of your insurance or in another province, you will need to take out private insurance that will be in effect from the moment you travel to Canada.

Booking a flight

- ✓ Make sure your immigration documents are approved before you buy a plane ticket.
- ✓ Check your airline's travel advice.
- ✓ There are two main airports in Quebec: Jean-Lesage airport in Quebec City and Pierre-Elliott-Trudeau airport in Montreal.

CLEARING CANADIAN CUSTOMS

Clearing Canadian customs

- Consult the <u>list of documents required</u> to enter Canada to be well prepared and keep them in your carry-on bag.
- When you arrive in Canada, at the first airport you visit, you'll have to pass two identity checks. You'll go through primary inspection at automated kiosks, then secondary inspection with border services officers. Allow 3 to 4 hours if you have a connecting light.
- Your study permit (if required) will be issued on site. Check your study permit to ensure that your personal information is correct and that it clearly states your right to work.

TRANSPORTATION

Your transportation from the airport to Université Laval

From Montreal's Pierre-Elliott-Trudeau airport

- Orléans Express buses have departures from the airport and downtown Montreal, several times a day. The journey takes about 3 hours.
- VIA Rail trains also run from Gare Centrale de Montréal to Gare du Palais (Quebec City Centre-Ville) and Gare de Sainte-Foy (closer to ULaval).
- You can also take a connecting flight to Québec City's Jean-Lesage airport.

From Jean-Lesage airport in Quebec City

- You can take bus number 76 from <u>réseau de transport de la capitale</u> (RTC) with a connection to the 800 or 801 to Université Laval.
- You can take RTC bus no. 80, which connects with no. 804 to Université Laval.
- You can also take a cab to your place of residence or see our <u>getting around</u> <u>page</u>.
